## WAIVER AND RELEASE OF LIABILITY

THIS AGREEMENT is entered into by and between Peace of Mind Dog Boarding LLC ("Daycare") and ("Owner") Dog(s) listed above.

1. By enrolling the above named and described dog(s), I represent that I am the legal owner of the named dog(s) and I assume all risks, dangers and responsibility for injuries to that named dog(s). Owner understands and agrees that Owner is solely responsible for any harm to Owner's dog(s) while Owner's dog(s) is/are in the care of Daycare.
2. Owner understands and agrees that during normal dog play and boarding, Owner's dog(s) may sustain injuries. All dog play and boarding is monitored to the best of our ability by Daycare to avoid injury, but scratches, punctures, torn ligaments and other injuries may occur despite the best supervision. Owner recognizes the risk of injury to dog(s) in our care even when directly supervised.

3. Owner further understands and agrees that neither Daycare nor any of its staff, will be liable for any illness, injury, death, and/or escape of Owner's dog(s) provided that reasonable care and precautions are followed, and Owner hereby releases all of them of any liability of any kind whatsoever arising from or as a result of Owner's dog(s) attending or participating in care at Daycare.
4. Owner further understands and agrees that Owner's have seen, inspected and/or understands we have only 4' wire fencing and are aware of the outside yard area used. Owner's dog(s) will have access to this fenced outside yard area Owner's agree to assume full liability if Owner's dog(s) escapes.
5. Owner further understands and is aware that Daycare uses crates. Owner understands that Owner's dog(s) may be contained and housed in a crate while indoors. Owner further understands that Daycare may use a "PetSafe" battery operated "static correction" collar to control barking if dog becomes a nuisance disrupting the "Peace Of Mind" of the other dogs.
6. Owner further understands and agrees to be responsible for any damages caused to home or property by Owner's dog(s) they will be liable for repair or replacement cost associated with the damage.
7. Owner further understands and agrees that if Owner's dog(s) is/are not picked up by the end of the scheduled regular business day, then Owner hereby expressly authorizes Daycare to take whatever action is deemed necessary for continuing care of Owner's dog(s) and owner agrees and promises to pay Daycare all costs for continuing such care upon demand by Daycare. Owner must maintain contact with Daycare to continue care or Owner's dog(s) will be considered abandoned. Daycare shall be authorized to proceed according to the local municipal code governing abandonment of animals.
8. Daycare is also authorized by signature below to seek emergency veterinarian care if felt necessary by Daycare with release from all liabilities related to transportation, treatment, and expense. Should specified veterinarian be unavailable, Daycare is authorized to approve medical and/or emergency treatment (excluding euthanasia) as recommended by a veterinarian available. Owner's agrees to reimburse Daycare for any expenses incurred, plus any additional fees for attending to this need. In the rare and unfortunate event that your pet dies in our care your pet will be taken to your designated veterinarian and maintained for pick-up or further instruction.
9. Owner shall release, indemnify, and agree to hold Daycare harmless from any and all manner of damages, claims, loss, liabilities, costs, or expenses, causes of actions or suits, whatsoever in law or equity, (including, without limitation, attorney's fees and related costs) arising out of or related to the services provided by Daycare, except which may arise from the sole gross negligence or intentional and willful misconduct of Daycare, including, without limitation, (1) any inaccuracy in any statement made by yourself or information provided by you to Daycare, (2) your dog, including but not limited to destruction of property, dog bites, injury, and transmission of disease, and (3) any action by yourself which is in breach of the terms and conditions of this agreement.

Owner hereby certifies that Owner has read and understands the Waiver and Release of Liability and regulations set forth above. By signing this agreement, Owner agrees to be bound by its terms and conditions.
